## Three Megatrends to Watch in 2023

## **Decentralization vs. Centralization**

All over the world, secessionist movements are pulling countries apart. The consequence is steadily eroding performance, and an increased frequency of complex system crashes. We all see this happening every day in all directions.

Governments seized control of social media to maintain centralized narrative control as they demonstrated wide-scale incompetence during Covid.

People noticed, and a new challenge emerged. Either companies and governments get serious about authenticity and decision quality, or they will begin to break apart. This is not meant to be a political statement but rather an application of the laws of thermodynamics to organizations.
